(Fran Zelinkoff): Based on new USAV rules, CSVA is adopting the following for the Fall 2015 League. a) As indicated in section #6e in the CSVA Rules Sheet, contact of ANY part of the net by ANY player involved in the act of playing or attempting to play the ball is a fault (the previous rule allowed contact with the net except for the top tape). b) A yellow card applies to the entire team for the entire match (see

previous rule allowed contact with the net except for the top tape). b) A yellow card applies to the entire team for the entire match (see section 11). Fran also issue a reminder that in divisions 1-3, only REGULAR substitutions are allowed (i.e., players cannot rotate into the

center back position). For the Huntsman tournament in October, 2015, the old net rule will apply.
